Rosalind Wiseman is the co-founder of the Empower Program, a non-profit organization that empowers youth to stop the culture of violence. Reaching over 5,000 youth and educators each year, Empower envisions a world where young people are safe from being bullied, harassed, or victimized by any form of degradation or violence.

She is the author Queen Bees and Wannabes: Helping Your Daughter Survive Cliques, Gossip, Boyfriends, and Other Realities of Adolescence. Twice a New York Times Bestseller, Queen Bees & Wannabes is in its 30th printing. Other recent publications include contributions to Education Digest and Principal leadership Magazine. Her new book Queen Bee Moms and Kingpin Dads: Dealing with the Parents, Teachers, Coaches, and Counselors That Can Make or Break Your Child's Future was released in 2006.

Wiseman speaks to children, teens, parents, and educational professionals throughout the world. Audiences have included the American School Counselors Association, National Education Association, Girl Scouts, Girls Association of Australia, Young Presidents Association, and the International Chiefs of Police.

She has been profiled in The New York Times, People, Los Angeles Times, Chicago Tribune, Washington Post, USA Today, Oprah, Nightline, The Today Show, CNN, Good Morning America, and National Public Radio affiliates throughout the country.

Wise is a recipient of the Lanterns Social Justice Award from the Black Women's Bar Association of Los Angeles. She is an advisory member of the Corporate Alliance to End Partner Violence and Liz Claiborne's Love is Not Abuse Campaign. She was a liaison to the American Bar Association's Domestic Violence Committee and a member of the Violence Against Women Act's Subcommittee on Girls and School Violence. She is certified through the Program for Young Negotiators at Harvard University and has a Bachelor or Arts in Political Science from Occidental College.
