- 6. Volleyball Camp, Grades 3-12 to be held on June 11-14, 2012, Norton High School, at a cost of \$50/each player and \$40/each additional family member for each clinic.

1. Basketball, Overnight, Boys, Grades 8-11 to be held December 26, 2012-January 2, 2013, Orlando Florida, at a cost of \$1100 (estimate).
