Please note, results of related investigations by school administration may be used to determine if there has also been a violation of the Student Code of Conduct. When a violation is known to have occurred, and not a suspected violation, the hearing process is waived.

Any other person who can offer appropriate assistance, such as parents, counselors, the athletic director, ("the district CARE coordinator" shall be removed as there is no longer a person in the district serving in this capacity), law enforcement officials, dependency specialists, etc. may assist the player in the development of the Improvement Plan.

8<sup>th</sup> Paragraph, Study Table guidelines.

#2, change to read: "Between a 1.0 and 1.49 GPA will be a probationary program in which the student must attend study tables three (3) days per week."

#3, change to read: "Between 1.5 and 1.99 GPA must attend study table 2 days per week."
