- A. Curriculum and Technology Angie Wagler passed out a copy of the summer workshop flyer and also a survey regarding smartboards/mimios. The Board will be asked to approve "Alert Now" at the next Board Meeting.
 - Sharon Herchik explained that the Social Studies text adoption is ready for 6th and 7th grades and is waiting for the 5th grade. She and the teachers visited the schools regarding the Inquiry based program it will be more work for the teachers, but they prefer the program. She also has worked on the business department text adoption because of Office 2007 it will be about \$25,000 for nine classes.
- B. Operations Committee Ken reported the cost to connect the M. S. water lines will be \$20,000.
- C. Policy Committee Valerie shared the "Child Find" brochure and explained that the MRDD budget was cut by 45% - these kids will now be our responsibility. They will be closing preschool for medically fragile students – one student involved – Valerie is working to get the student to stay in daycare and we will provide itinerate preschool services.
 - Dave Dunn reported that MRDD was notified of child abuse allegations- in response we will be installing cameras to check classroom. A teacher was suspended for three days for failing to do IEP's.
- D. Community Engagement Committee –Dave is finishing editing the newsletter. The May 12th community meeting is the "kick-off" for Norton City Schools' future. We have received notification that we have been approved for OSFC funding. In early June we will have a pull-out section in the Herald and will print a school calendar with school info and important dates on it.
- E. Finance Committee Stephanie did a presentation on the 5 Year Forecast. At this point, we are in the black through 2011.
