Mr. Dunn – Only motivation is the best interest of the kids– contracts were his recommendation.

Mrs. Bennett – The 2 board members could ask for contracts –it is a non-issue – these administrators received excellent reviews, want to retain people that are valued –there was no ill motive. Didn't ask people to come – that is not an issue.

Mrs. Jeffries – Contract gate – just because said over and over does not make it true – would like facts – contracts are available – retaliation –she has spoken up many times and nothing happened to her – speak out if you have opinion – Board is true – it will be a smooth transition with trained professionals.

Mr. Sams – Has received several calls about retaliation from individuals.

Mrs. Jan Nutter – Security person – do not need – staff and schools in good shape. Police close, no need.

Mr. Ule – Has a young son, the school does a great job they had a popsicle party before school started to make it easy for kids.

Mrs. Bennett – Contracts – if any board member wanted to review specific issue they could have – legally able to do – people on the board vote no for no reason – put negative light on reputation, and is not transparent.

Mr. Sams – Board policy says it is ok to do that.

Mrs. Bennett –Yes is allowed, but think that is not right.
