EXECUTIVE SESSION

President Bennett called the meeting back to public session at 7:28 p.m.

PUBLIC PARTICIPATION/VISITORS/GUESTS

Mr. David Houpt – Read the following:

"There is instability in the Norton School Board's 3 controlling members to the voters and tax payers who support the school. Early 2015, 2 board members voted no to giving the secretary treasure 12.5% raise of \$10,000. Both citing had economic conditions and the School System running out of money in the next 18-24 months. The 3 controlling members voted in the raise.

Then came the loaded meeting with teachers who booed and disrupted the meeting. Madam President failed to gavel the meeting into order. Then came the end around vote in the contracts 18 months early, now known as CONTRACT GATE. This vote was ask by president of the board with out giving copies of the contract to all board members. Over \$3 million in contracts with board members NOT seeing what they were voting on. Along with this came the superintendent saying Ohio State School Board told him to offer contract early, we found out that was false. This breeds instability.

When I introduced CONTRACT GATE the secretary treasure said we have 5 to 6 years of operating funds. Indicating the 4.5 years of contracts, we had the money to fund. To see contract gate in its entirety, go to YouTube then HOUPT NORTON you will see the video.

Now at the last meeting of the whole, it was said we have enough money to operate 2 years and then we will be out of money. The liberal board members want to put an operating levy on the next election. Truth breeds instability. We have one more example of why this board is not stable.

During this time the secretary failed to limit the liberals to the allotted 5 minutes speaking time but shut down the conservative speakers at exactly 5 minutes. Madam President did admit her personal campaign finance treasure was allowed to speak over the 5 minutes. I submitted a course of action request to seek remedy for dereliction of duty to call time. No response. Again this breeds instability.

Now we have the issue with an employee. Madam President failed to follow the ORC in calling an executive meeting. Two newspapers stated this was a violation of the ORC and one conservative board member said he was not comfortable with this meeting. This did not matter to the liberals. The next 2 executive sessions were called using the ORC rules. This causes instability.

In closing, I have repeatedly ask the controlling members of this board to speak the truth and be transparent. They have failed. The Barberton Herald and my self have ask for copies of the contracts of all administrators, only cover letters were provided, no

salary information was given. As we speak the auditor of the State of Ohio is investigating this failure to follow the sunshine law.

In any relationship weather it he one with you and family member or school hoard and tax payers truthfulness is required. We have been failed by the controlling members of this hoard. It is time to get members on this hoard that can tell the truth and restore stability in the Norton School Board."

Mr. Dunn – Addressed Mr. Houpt – Before you said I said ODE told me, today you say OSBA – It was completely his decision to present administrators' contracts, the law provides the opportunity, no one told him to do it. Executive Session – checked with our attorney – assured we are in compliance with the Sunshine Law.

Mrs. Bennett – This is 6th or 7th time administrators' contracts have been brought up – can't control if board members don't ask for copies prior to vote – no raises given and we are retaining qualified individuals. There is no hidden agenda, just wanting to keep good people. To vote no without reason, that is instability. Finance is difficult to understand and predict – changes with state budget and property values – we passed a 1.9 mill levy, 3rd lowest in Summit County – others have pay to play. There was a change to the budget, not misleading. There is no ill motive – not bad people – it is a non-issue – Let's talk about wonderful things kids do.

Mrs. Bennett asked to move Norton Kiwanis out of Public Participation – no objections.
