PUBLIC PARTICIPATION/VISITORS/GUESTS

Mr. David Houpt – Contract Gate -Upset with Administration Contracts – feels there were lies about the administrator contracts being given early. Upset with the actions of the teachers at the last board meeting, he feels they took control of the room and were unprofessional. Upset that the Board allowed a teacher to speak as a union representative when she is not a union representative. Upset that Board would allow teacher to talk when she said she was representing the administrators because they are not in a union. Would like to see resignations from the Superintendent, Treasurer and 3 board members. He wants the truth from Board and administrators, he feels he is not getting it.

Mrs. Nancy Jeffries – II Corinthians Chapter 8 asks what is your motivation – her motivation is facts - has no hidden agenda and is only stating the facts. Need to stop this back and forth - focus on the good – since 2004, the District has received an Excellent rating, now received an A in state standards. If there are questions ask them in private not public, just go ask questions. She did not act as union representative, just as a representative of group and only supporting the administrators never said she represented them.

Mr. Louis Ule – Would like the Board to reconsider talks about school resource officer (SRO) and be open to talks –He feels an SRO would be successful – both school and city will benefit from this. SRO knows the students. Try to work this out with the city, it’s important for school – many surrounding areas have this.

STUDENT RECOGNITION

Mrs. Pletcher – Introduced Coach Paridon and Steven Planitzer. Steven went to Dallas, Texas for national competition. Steven competed in congressional debate and made it to finals – he placed 11th in the nation!

Nursing – Clair Coughenour and Miranda Cope received a Gold medal at the state “Career Pathway Showcase Health” competition. Katie Johnson placed 1st at the Skills USA competition.

Track – Congratulations to: Rachel Borton and Matt Bradshaw both placed first in the PTC for discus - Sydney Hagenbush placed second for high jump and third for hurdles and Colin Hagenbush placed third in the 400.

CONSTRUCTION UPDATE

Matt Collier – CT Taylor – Reviewed sight plans and explained the progress of the building - the footers are in process - about 1/3 finished. Discussed the issues with the rain fall and drainage of water off of the property – the grade of the property has not changed, nor are they introducing new water. They have reviewed plans with the architect and civil engineer to try to alleviate some of the concerns. Added new catch basins at the northeast to slow the water. This will be ongoing process to work through – want to be part of the solution to an old problem. Reviewed the modified building schedule – completion date of November 2016. The bids were significantly under budget which allowed the district to include several alternates – terrazzo floor in the entry way; rubber floor in classrooms, hallways and student dining area; concert shell in the auditorium; paving the drive out to Easton Rd; and emergency call buttons in each room. We are not millions of dollars over budget – we bought \$650,000 worth of alternates and put a significant amount of money back for later options.
