Norton Primary – The Norton Developmental Preschool would like to thank Dr. Jennifer Jerome for her classroom visits as one of our community partnered dentists. We would like to thank the Builder’s Club students and Dr. Russo for volunteering again in Kindergarten. Their first session with students was on Wednesday, January 31st. They will work with the Kindergarten classes every Wednesday for the remainder of the school year. February 13th is the 100th Day of Kindergarten. February 21st is Mobile Dental Services. February 23rd is Peer Screening for 24-25 Preschool Students. February 23th – March 1st is Right to Read Week.

Norton High – February 27th, we will be administering the ACT to all juniors. Our counselors will be getting all the students pre-registered prior to the 27th so testing will run smoothly. We will be using the paper/pencil test this year and parents can expect results in a few weeks. Speech and Debate had a fantastic day at their district meet on February 3rd. Fourteen students qualified for the state meet. This is the largest number we’ve had qualify to the state meet in over 10 years. Congratulations to coaches, Tricia Pletcher, Anthony Paridon, and Madison Juersivich for all their hard work. Our girls bowling team, boys basketball team, and girls basketball team have all won MAC championships. District tournaments for all these sports and wrestling begin in the next few weeks. February 12th and 13th, all sophomores will be trained in the use of AED’s as well as how to administer CPR. This is a state law that all students have this training before graduating from high school. We complete this every year with our sophomore class. Special thanks to Chief Shultz on the Norton Fire Department and his crew for helping with this and giving the students hands on training.
