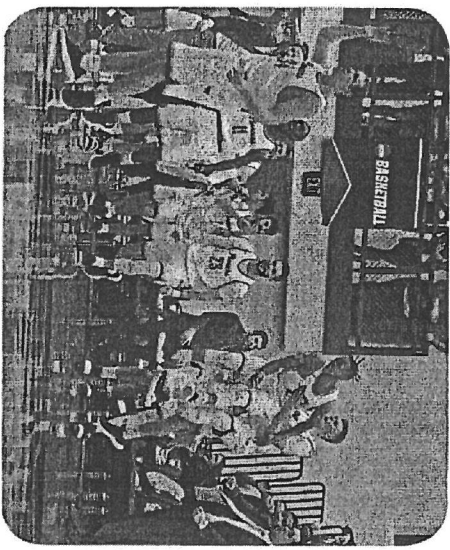

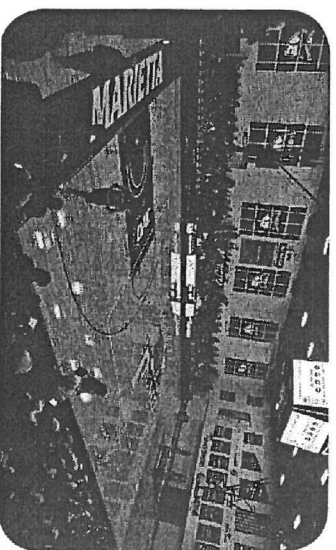

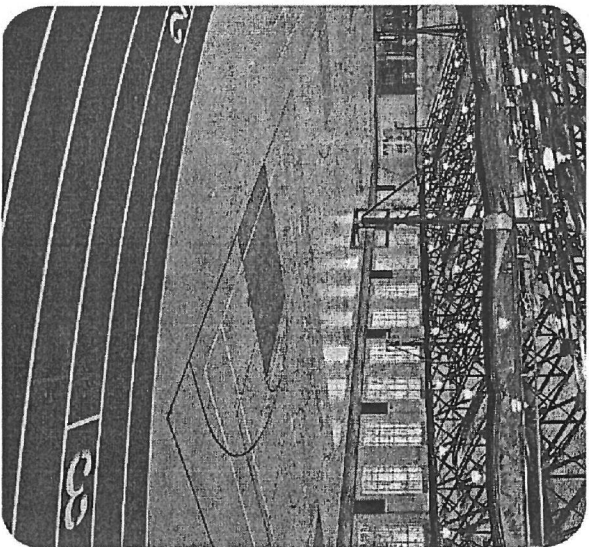
PIONEER SHOOTOUT INFORMATION
