- B. Finance** – We had a request to increase field trip transportation budgets, Dave and Stephanie will review the cost of all transportation at the end of the year and make a recommendation for any changes.

- D. Community Engagement** – Working on Community Service Committee. The director of Barberton Area Community Ministries, Joanne Cramer, has agreed to serve as the community member. Also feel the students should be the President of NHS & Class President.

4. Girls Basketball Camp, Grades 1-6 to be held June 7-8, 2013 at Norton High School, at a cost of \$30/each participant.
5. Girls Basketball Camp, Grades 7-8 to be held June 10-12, 2013 at Norton High School, at a cost of \$40/each participant.
6. Girls Basketball Camp, Grades 9-12 to be held June 3-5, 2013 at Norton High School, at a cost of \$50/each participant.
