COMMITTEE REPORTS

Operations: - District has received the BWC Safety Grant, will update cameras and add additional ones to buildings where needed. Ordered and placed signs to increase awareness of passing a stopped bus. Athletics will be in a new league next year.

Finance: - Held a meeting on November 13 – discussed income tax collections and the valuation of the pipeline. The forecast is on the agenda for approval and the district is officially on Ohio Checkbook.

Policy: - Met October 23 – review new policy updates from OSBA. The first readings will be on the agenda this evening. One to note – the district will be tobacco free, no smoking on school property.

Community Engagement: - no meeting, Mr. Santelli reviewed information he obtained at Capital Conference.

Technology & Instruction: - **Technology** – new forms for students and staff when they sign out devices, it will create accountability. Network upgrades are complete and e-rate was approved, we should receive \$53,000; if e-rate doesn't continue to support wireless, our cost will increase approximately \$8,000 per year. Received \$4,000 grant from Best Buy for coding again. **Curriculum** – Camp Invention will take place next June (no cost to the district). The next Professional Development day is November 27.
