

## **Guided Transitions for Supported Individuals**, LLC.

Entered on this day between Norton City Schools and Guided Transitions for Supported Individuals, LLC in regard to ("Student").

Whereas, Guided Transitions for Supported Individuals, LLC has expertise in the development, implementation, and supervision of an educational program known as Guided Transitions High School.

Whereas, Norton City Schools wishes to contract Guided Transitions for Supported Individuals, LLC in an advisory capacity to assist in developing and maintaining Guided Transitions High School for their student; and

Whereas, the Parties wish to document their understanding of their relationship with respect to the development, implementation and supervision of the Guided Transitions High School program for ("Student").

## Program Cost-

\$50,000 for education and vocation program would be divided into monthly payments of \$4,166.66 due the 1<sup>st</sup> of each month during the span of July 1st, 2018 - June 30th, 2019. If Program is pre-paid for full 12 months, a 15% discount is given. If you pre-pay, \$42,500.00 is due by June 29th, 2018.

- Follow Guided Transitions High School Calendar for the academic school year and beginning of summer program until next contract begins.
- Community, Home, Vocational, Accommodation Assessments completed upon intake by Guided Transitions for Supported Individuals, LLC staff
- Student WILL be provided a One to One staff support for behavior interventions
- De-escalation and Behavioral Support
- Academic, Behavior, and Vocation data provided upon request at any time by district or parent as well as quarterly progress reports

- Speech Therapist Assessment and Consultation as listed in IEP
- Occupational Therapist Assessment and Consultation as listed in IFP
- BCBA Assessment and Consultation as necessary by team or district collaboration
- Yearly Meetings with District to discuss progress and collaborate for IEP/ETR development
- Program Implementation that includes a highly structured environment, PBIS, TEACCH, Love & Logic, and ABA aspects
- Employment and Functional Life Skills and Implementation
- Co-Collaborative Transition Plan

Norton City Schools District and Guided Transitions for Supported Individuals, LLC has the right to terminate this contract with written notice under a 60 day notice. Guided Transitions for Supported Individuals, LLC will invoice for services and approved expenses up until the final day student was receiving services. If program is not fulfilled from July 1<sup>st</sup>, 2018 through June 30<sup>th</sup>, 2019, a prorated refund will be provided to Norton City Schools District.
