

Purchasing Terms

Northeast Ohio Network for Educational Technology

This Memorandum of Understanding (MOU) is entered into by the Metropolitan Regional Service Council on behalf of the Northeast Ohio Network for Educational Technology, referred to as "NEOnet" and the Norton City Schools referred to as "District" and is effective as of the signature date. As the owners of NEOnet, the District agrees that NEOnet will maintain and own the devices for one year from the time of shipment and will process all warranty claims on the devices during that term. At the end of the one-year term the district will be transferred full ownership of the device. This is a requirement of the manufacturer to take advantage of consortium pricing.

This MOU can only be modified by the written agreement of all parties. These modifications will be executed as amendments to the original MOU. The terms and conditions of this agreement shall be construed in accordance with the applicable laws and rules of the State of Ohio and the United States, and only Ohio courts shall have jurisdiction over any action or proceeding concerning this agreement and/or performance hereunder.
