Section 2: The Board hereby authorizes and directs the Treasurer and Board President to execute the Agreement for Sale of Real Estate attached hereto as Exhibit A and the Quit-Claim Deed attached hereto as Exhibit B, and do all other necessary and consistent with this resolution, in order to accomplish the sale in accordance with the terms and conditions set forth in the Agreement for Sale of Real Estate, which are incorporated herein and made a part hereof by reference.

Section 3: It is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of the Board, and that all deliberations of this Board and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code and any amendments thereto.

NOW, THEREFORE, BE IT RESOLVED:

Section 1. Section 3. The Superintendent and Treasurer are hereby authorized and directed to take all necessary steps to implement the reduction in force on August 1, 2024. The Treasurer is further directed to provide written notice to the Association President, and all affected employees, of this action.
