BOARD REPORT

Primary – Kindergarten “Weeks of Welcome” have started and are off to a great start! Kindergarten Screening was held June 1st and 2nd at Grace Church. The Kindergarten Assessment Team completed 91 screenings over the two days. Popsicles, Playground, and Play kicked off June 6th. Literacy on the Lawn kicked off the evening of June 6th, at the Norton Branch Library. Many families from Norton Primary and Norton Elementary attended. Kindergarten Safety Town was a success. We are currently enrolling students in the Get Ready for School Program, which will be the first 2 weeks in August for eligible Kindergarten Students.

Norton Elementary – Camp Invention is June 12th -16th. The Summer Reading Program is every Wednesday throughout the summer. Literacy on the Lawn is June 6th, July 11th, and August 15th, at the Norton Library. There are read-alouds, crafts and more.

Norton Middle – Extended school year and summer school are underway for qualifying students. Our 5th grade hallway is in the process of being painted, including lockers. 5th grade summer reading lists are available on the website. If students need to borrow books, they are available at the main entrance of the school. August 16th, 5th grade students will be invited to the school for activities led by the staff and 8th grade peer mentors.
