#### **BOARD BUSINESS**

Discuss Graduation Procedures:

At the last meeting, the Board voted against allowing the Valedictorian and Salutatorian to speak.

Mr. Sams – There is not a policy. It is not changing for one student - Had no message or call against this; still for her speaking.

**Mr. Sams** moved that the Board of Education allow the Valedictorian to speak at Commencement for up to 5 minutes.

## Discussion:

Mrs. Webel – There is a change offered from committee; came from Graduation Committee.

Mr. Sams – Mr. Knight wanted compromise; her speech is 4.5 minutes.

The 2014 Class Valedictorian will be offered the opportunity to address the Senior Class after she is recognized as the Class Valedictorian.

The Top Ten Students will be recognized from tenth to first place. After the Valedictorian receives his/her medallion and plaque, the High School Principal will take a moment to say a few words about the student. He will introduce the Valedictorian, who will be allowed to deliver a pre-approved address to her classmates. The printed address should be no more than two minutes long and delivered in writing to Mrs. Ward: Senior Class Advisor, and Mr. McBride, no later than Tuesday, May 27th, for editing and/or approval. Additionally, the Valedictorian must present his/her address verbally to Mrs. Ward and Mr. McBride at that time.

Mr. Matt Housley – 1982 Valedictorian Sandy Suppan – thought Valedictorian should get to speak; He has petition from change.org with 343 signatures; states Valedictorian should have opportunity to speak; read a few comments – thinks by definition Valedictorian should have opportunity to speak; how do we grow without change; need to challenge to make changes; people make changes – Please reconsider your decision – Sorry people were not nice and disrespectful – Board has his complete respect, proud to be from Norton – need good change.

Mrs. Bennett – Address Valedictorian– please know this is not directed to her – it's at procedures.

Ms. Krawczck – didn't think she was "featured" speaker – thought as Valedictorian she had a right to speak.

Mr. Housley - President gets to speak, not fair

Pat Milhof – both sides are digging in – need to make compromise – doesn't know why we don't do this – please change for future- time to change procedure.

Mr. Sams – appreciate people coming to talk- recognize not easy to do – believe only have best interest of district at heart – thanks to Board for coming back to reconsider this.
