## *Welcome to Norton City Schools!*

In order to enroll your child at Norton City Schools you must be a resident of the Norton City School District. If you are not sure, you may visit the Summit County Auditor’s “Property and Tax Appraisal” webpage at <https://fiscaloffice.summitoh.net>. Follow the prompts and enter you house number and street name to determine your school district of residence. You may also call the enrollment office at (330)706-2723, and your address may be looked up for you.

Once you have determined your district of residence is Norton, you may either print enrollment packets from our website or pick up packets at the Administrative Office (located at 4128 Cleveland-Massillon Road) during regular office hours. Please park in the lot between the empty lot on the corner of Cleve-Mass and Greenwich roads and McDonalds. Admin Office is located in building at the back of that lot.

Details regarding required registration documents are listed on the cover page of each enrollment packet. Please be sure to provide all required documents. **Your child’s enrollment could be delayed due to missing documentation.**

If you are living with another family and are unable to provide proof of residency, you may complete a residency affidavit with the homeowner which may also be printed from our website. If your situation falls under McKinney-Vento Homeless Act provisions, you will not be required to complete this paperwork. Please contact the enrollment office for further information regarding eligibility.
